RENTAL TERMS AND CONDITIONS

1. All tent rental items will be delivered and set up at the location specified as "Place of Use" as noted above by the RENTER. The tent will be picked up no later than one day after the day of rental. Tables and chairs are the responsibility of the RENTER to set up and take down.
2. The rate of the rental agreement is based on one full day that starts at 7:00 am to 10:00 pm unless otherwise agreed by both parties. Set up and take downs may take place the day before or the day after the rental date.
3. The deposit of 50% of the total bill is non-refundable and is due at the time of the contract to hold the date of rental. The remaining balance is due at the time of delivery.
4. The RENTER shall pay the OWNER full compensation for replacement for replacement and/or repair of any equipment which is not returned because it is lost or stolen or any equipment which is damaged and in need of repair to put it into the same condition it was in at the time of rental, normal wear and tear excepted. The OWNER's invoice for replacement or repair is conclusive as to the amount RENTER shall pay under this paragraph for repair or replacement.
5. The RENTER shall not remove the equipment from the address of the RENTER or the location shown herein as the place of use of the equipment without prior written approval of the OWNER. The RENTER shall inform the OWNER upon demand of the exact location of the equipment while it is in the RENTER's possession.
6. Owner is not liable for set-up failures due to weather related conditions that result in personal injury. RENTER needs to take cover in solid building structure when weather conditions are not conducive to outdoor activity.
7. Owner is not responsible for any damage to sprinkler systems during the installation or take down of tents but will work cautiously to avoid water lines and sprinkler heads while driving hold down stakes for tent assemblies.
8. The equipment shall be delivered to RENTER and returned to OWNER at the RENTER's risk, cost and expense. If a periodic rental rate is charged by OWNER, rental charges are billed to the RENTER for each period or portions of the period from the time the equipment is delivered to RENTER until its return. If a term rental rate is charged by OWNER, rental charges are billed to the RENTER for the full term even if the equipment is returned before the end of the term. If the equipment is not returned during or at the end of the term, then the rental charges shall continue on a full term basis for any additional term or portion thereof until the equipment is returned.
9. The RENTER shall allow OWNER to enter RENTER's premises where the rented equipment is stored or used at all reasonable times to locate and inspect the state and condition of the rented equipment. If the RENTER is in default of any of the terms and conditions of this agreement, the OWNER, and his agents, at the RENTER's risk, cost and expense may at any time enter the RENTER's premises where the rented equipment is stored or used at all time and recover the rented equipment.



RENTAL TERMS AND CONDITIONS

10. The RENTER shall not pledge or encumber the rented equipment in any way. The OWNER may terminate this agreement immediately upon the failure of RENTER to make rental payments when due, or upon RENTER's filing for protection from creditors in any court of competent jurisdiction.
11. RENTER indemnifies and holds OWNER harmless for all injuries or damage of any kind for repossession and for all consequential and special damages for any claimed breach of warranty.
12. The RENTER shall pay all reasonable attorney and other fees, the expenses and costs incurred by OWNER in protection its rights under this rental agreement and for any action taken OWNER to collect any amounts due the OWNER under this rental agreement.
13. These terms are accepted by the RENTER upon delivery of the terms to the RENTER or the agent or other representative of RENTER.
